


Fig.2 On-state current vs. Ambient temperature




Fig.3 Minimun Trigger Current vs Ambient temperature



Fig.4 Forward current vs Forward Voltage








Fig.5 On-state voltage vs Ambient temperature

Fig.7 Repetitive peak off-state current vs Temperature




Fig.8 On-state current vs On-state voltage




Fig.9 Basic Operation Circuit Medium/High Power Triac Drive Circuit







Fig.10 Static dv/dt Test Circuit & Waveform




