

WMO10P10TS uses advanced power trench technology that has been especially tailored to minimize the on-state resistance and yet maintain superior switching performance.








Figure A. Gate Charge Test Circuit & Waveforms




Figure B. Switching Test Circuit & Waveforms







Figure C. Unclamped Inductive Switching Circuit & Waveforms


