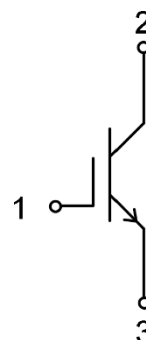
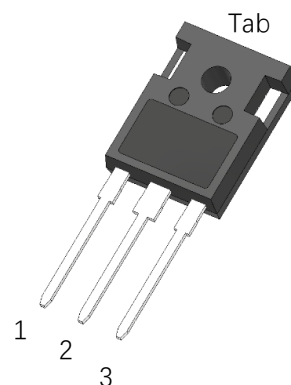

 $I_C=f(V_{CE})$, $T_{vj}=25^{\circ}\text{C}$

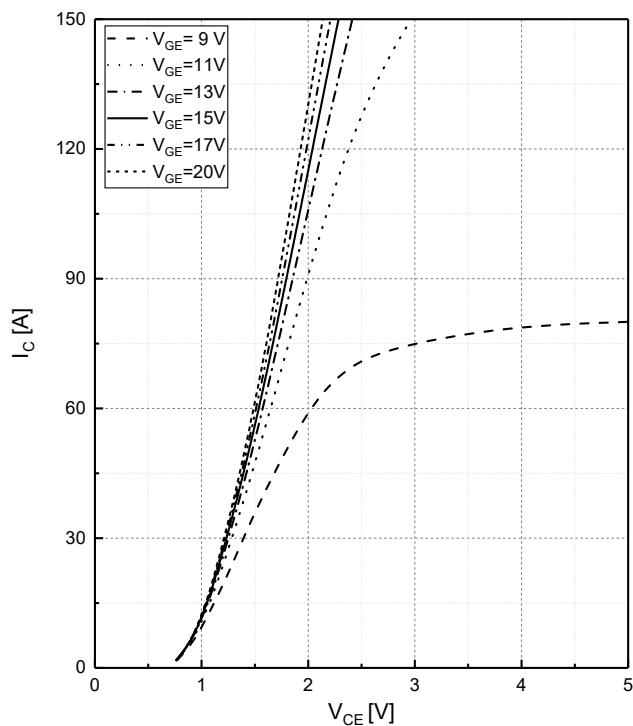


Fig.2 Typical output characteristic
 $I_C=f(V_{CE})$, $T_{vj}=150^{\circ}\text{C}$

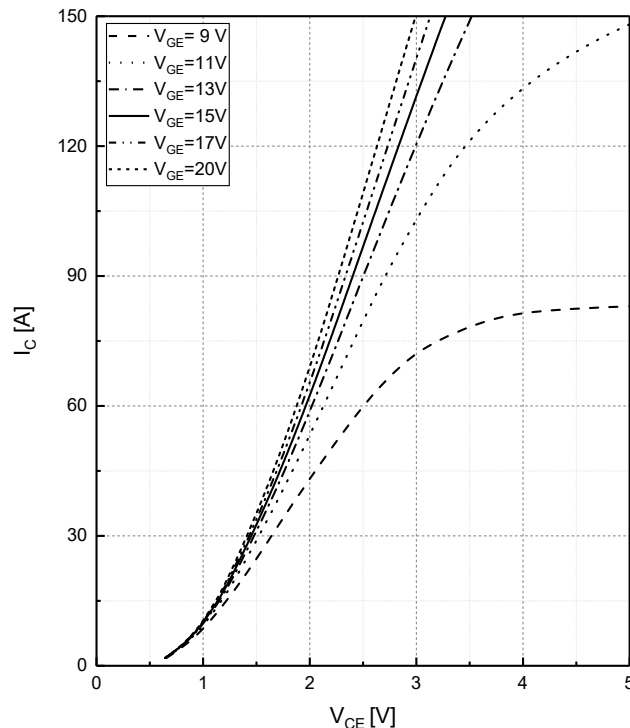


Fig.3 Typical transfer characteristic
 $I_C=f(V_{GE})$, $V_{CE}=20\text{V}$

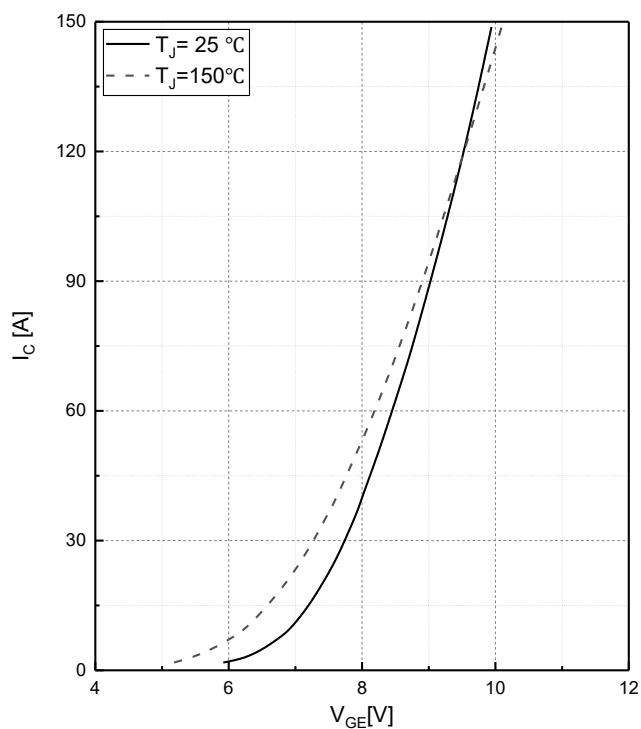


Fig.4 Typical $V_{GE(th)}$ as a function of T_{vj}
 $V_{GE(th)}=f(T_{vj})$, $I_C=1\text{mA}$

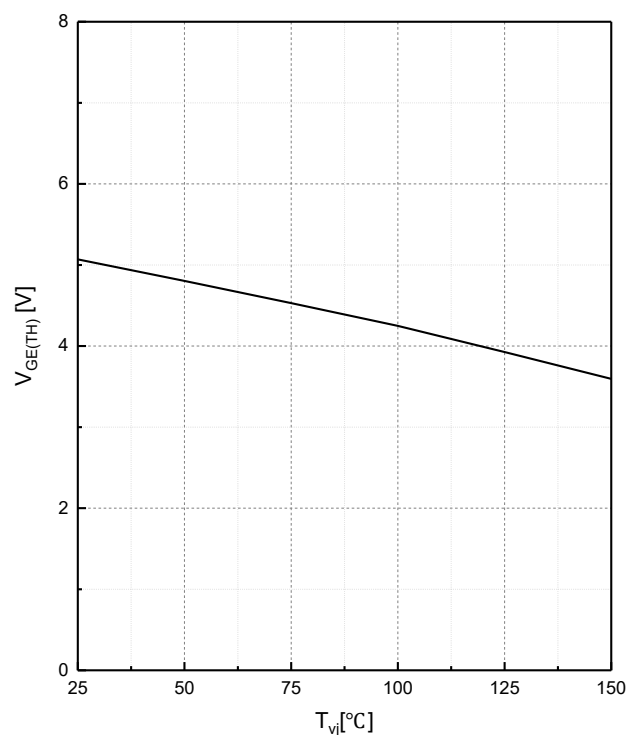


Fig.5 Typical V_{CEsat} as a function of T_{vj}
 $V_{CEsat}=f(T_{vj})$, $V_{GE}=15V$

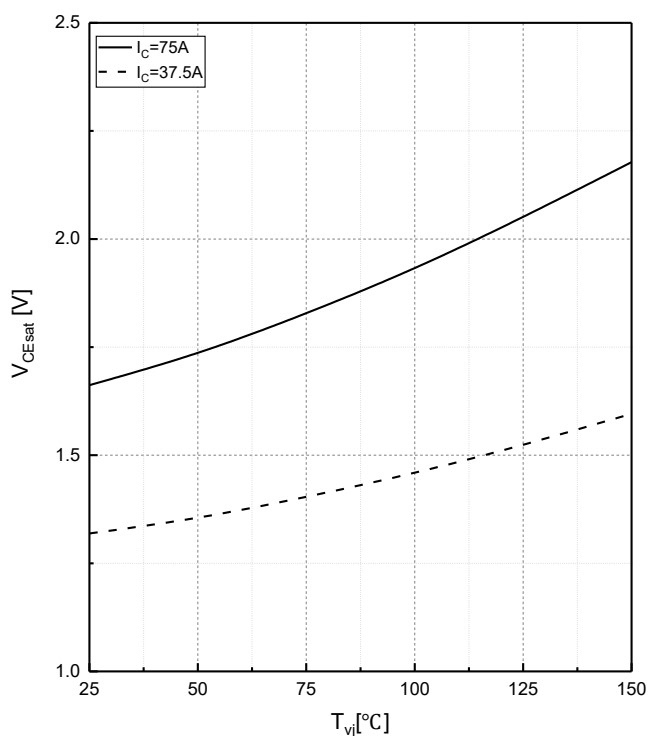


Fig.6 Typical Gate charge
 $V_{GE}=f(Q_G)$, $I_C=75A$

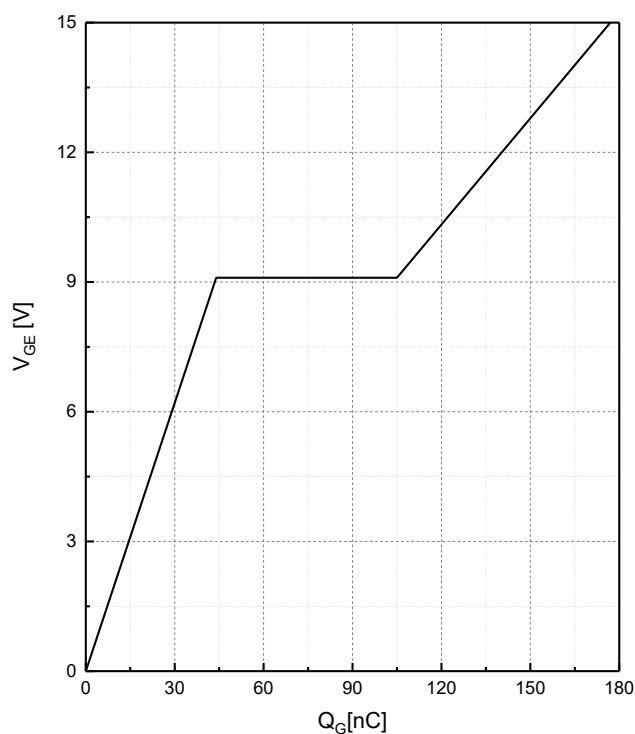


Fig.7 Typical capacitance as a function of V_{CE}
 $C=f(V_{CE})$, $f=1MHz$, $V_{GE}=0V$

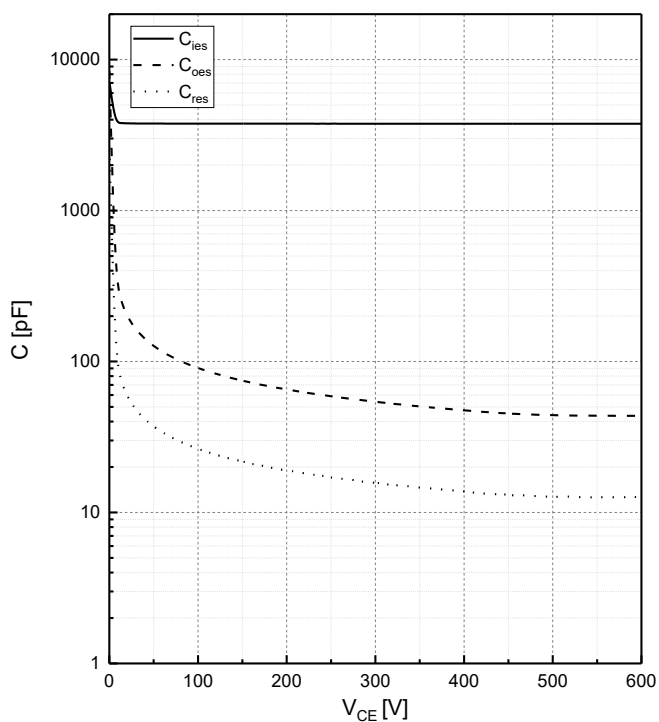


Fig.8 Power dissipation as a function of T_C
 $P_{tot}=f(T_C)$, $T_{vj} \leq 175^\circ C$

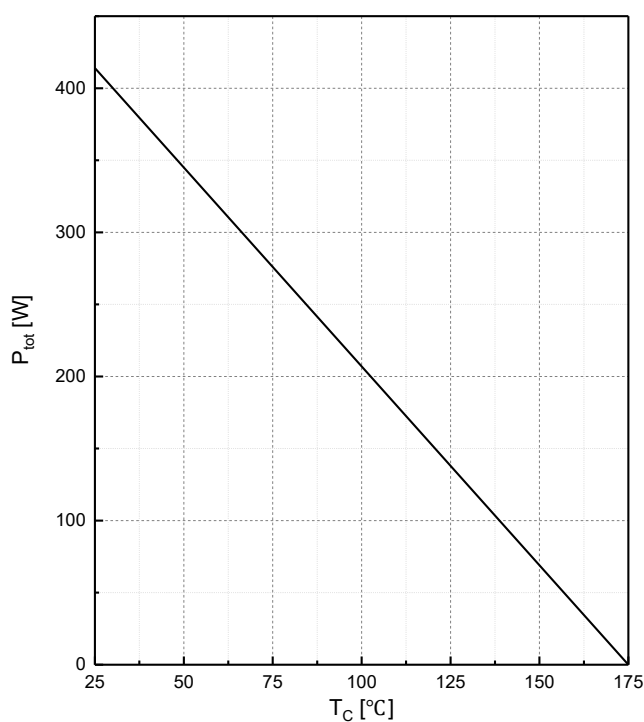
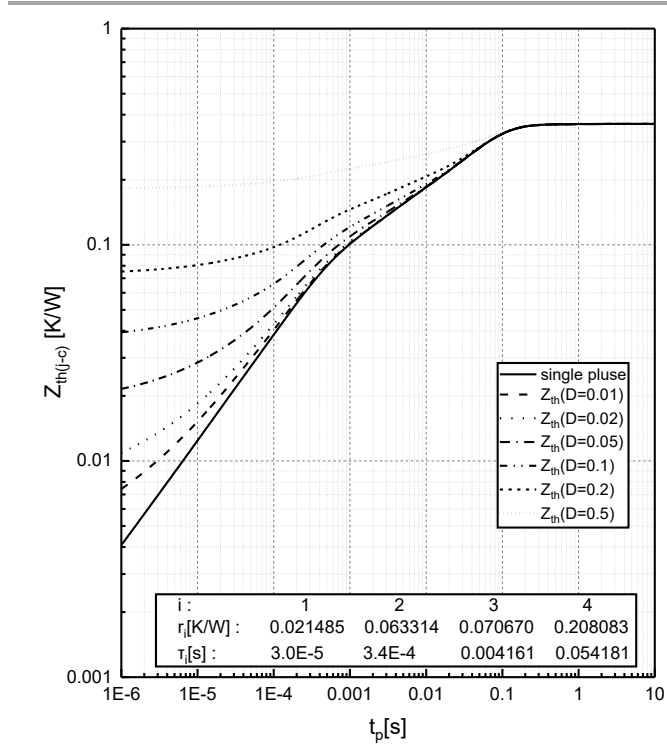
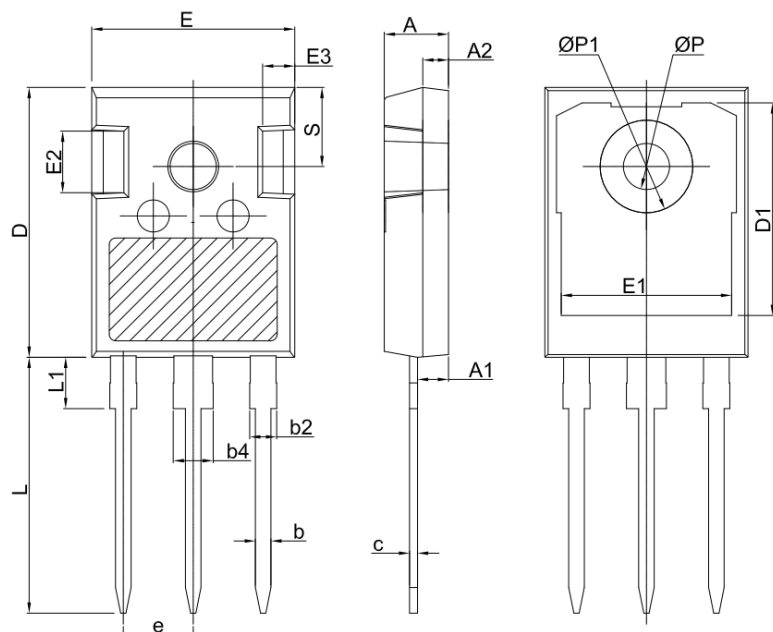


Fig.9 Transient thermal impedance of IGBT
